Canada (Government- Assisted Refugees (GAR) program)	individuals who have refugee status and are considering resettlement in Canada (applicable to syrians, iraqis, etc), so all countries of origin.	Refugees are referred for resettlement to Canada by UNHCR and other partners with which Canada has an agreement. Refugees must be registered with UNHCR or the state authorities in the country where they found asylum to be considered for referral. Those who benefit from the program receive financial support from the Canadian government for up to one year from the date they arrive in Canada.	The individual must register for refugee status with the UNHCR or state authorities to be considered by a referral organization. A GAR's initial resettlement in Canada is entirely supported by the Government of Canada or the province of Quebec. Canada (Private Sponsorship of Refugees (PSR) program)	The Private Sponsorship of Refugees (PSR) program allows Canadians to resettle specific individuals or families who qualify as refugees under Canada's refugee and humanitarian program. Privately sponsored refugees are additional to those resettled by the Canadian government through other programs. Privately sponsored refugees are approved outside of	Criteria for Sponsoring: Any person who by reason of a well- founded fear of persecution because of race, religion, nationality, membership in a particular social group or political opinion: is outside each of their countries of nationality and is unable or, by reason of that fear, unwilling to avail themselves of the protection of each of those countries, or does not have a country of nationality and is outside the country of their former habitual residence and is unable or, by reason of that fear, unwilling to return to that country; and is outside Canada is seeking resettlement in Canada	There is an application that has to be filled by the sponsoring group or individual.
